## Changes in the Call for KAKENHI Proposals for Fiscal Year 2025

About linkage between the information on research integrity registered in e-Rad and the KAKENHI Electronic Application System

## 1. Issues and Background Regarding Ensuring Soundness and Fairness in Research (Research Integrity)

In recent years, it has been pointed out that while globalization of research activities has been progressing, concerns about unintended conflicts of interest and technology outflows by researchers from Japanese companies and universities have become apparent due to undue influence from foreign governments and institutions on researchers.

In order to cope with these new risks and promote necessary international cooperation, it is necessary to ensure the soundness and fairness of research (research integrity) and to build an internationally reliable research environment.

## 2. Measures for Research Integrity in Grants-in-Aid for Scientific Research (Changes in the 2025 Grants-in-Aid for Scientific Research Announcement)


Based on the above background, information on research integrity registered in e-Rad will be linked to the Grants-in-Aid for Scientific Research e-Application System starting with the FY2025 public call for Grants-in-Aid for Scientific Research. Please note that both Principal Investigators and Sub-Principal Investigators who have not registered their research integrity information in e-Rad's "Researcher Information" will not be able to apply for the grant.

If you are considering applying for Grants-in-Aid for Scientific Research in FY2025 or later, please refer to the registration instructions below and be sure to register before applying.
