

## INTEGRATION

### 

- Absence of human rights attention in current international environmental laws
- UNFCCC, CBDR/RC (Common but Different Responsibilities): Powerful states are responsible for assisting developing countries
- Developing countries face more vulnerability to climate change
- Lack of Fundamental rights in environments, the standard of living, and the highest attainable standard of physical and mental well-being (United Nations, n.d.)
- Human rights should be included in international environmental laws

### CASE STUDY

Due to irregular rainfall and rising sea levels, the freshwater supply for the Maldives islanders is rapidly diminishing, leading to severe water shortages, increased household expenses, and heightened health and safety risks. At the same time, the islanders' agriculture has been significantly impacted by erratic monsoons, and fish populations are gradually declining due to overfishing, threatening both food security and income. These issues highlight the farreaching impacts of climate change on people's lives. The climate crisis is not only a threat to the planet but also to human ways of life, underscoring the urgent need for environmental laws that protect human rights.

- In integrating human rights, human-based considerations through the CBDR-RC system opens the door for more open support to those affected by these climate events.
