# Second-phase Program for Asia-Japan Research Development AY2024 Application Guidelines

#### 1. Purpose and Characteristics of the Program for Asia-Japan Research Development

The Ritsumeikan Asia-Japan Research Organization has been making every effort to advance research on Asia and Japan at Ritsumeikan University, thereby contributing to multicultural symbiosis in Asia, making Asia-Japan studies at the University better-known globally, and raising the University's profile as a global research university in Japan and overseas. These goals have been set based on the University's mission as a university in the Asia Pacific region stated in the Ritsumeikan Charter and on the R2030 Academy Vision, dubbed "Challenge your mind, Change our future."

As part of such efforts, the Ritsumeikan Asia-Japan Research Organization launched the Program for Asia-Japan Research Development in 2016. Under the program, the Ritsumeikan Asia-Japan Research Organization has domestically and internationally disseminated achievements made through a total of 15 research projects undertaken in the three areas of Symbiosis, Co-creation and Reconciliation.

In order "to realize a next-generation research university that generates new social symbiotic values and emergent human resources" proposed in the R2030 Academy Vision, we are now open for applications for original research projects in the three areas of "Symbiosis," "Co-creation," and "Co-commitment" in order to further develop Asia-Japan studies at Ritsumeikan University, promote research with a unique concept and strategy, and further increase our contribution to the world.

#### 2. Subject of Academic Research

In the Program for Asia-Japan Research Development, research projects that aim for "The Resolution of Various Issues in Asia" will be adopted based on the three research areas of "Symbiosis," "Co-creation," and "Co-commitment." The following are examples of some research topics that are presumed to be explored through research projects, but the research topics to be encouraged shall not be limited to these.

# 3. Program Details

This program consists of three research areas (Symbiosis, Co-creation, and Co-commitment), and a maximum of three projects will be adopted each academic year. The participation of other universities and companies in the projects, especially the cooperation of overseas universities, and the invention of these types of plans is particularly sought after. One or more graduate students must participate in each project and the participation of female researchers is strongly encouraged.

A project is composed of a project leader, project members, early-career researchers (\*), and graduate students. Their eligibility and roles are as follows.

\*Early-career researchers in the Program for Asia-Japan Research Development refer to those employed on a fixed-term basis as research professors (assistant professors), senior researchers or researchers. Requirements, such as age and the number of years after degree acquisition, are not established for their employment.

Project leader	The project leader is a qualified full-time Professor or Associate Professor at
	Ritsumeikan University and bears responsibility to complete the project during
	their career at Ritsumeikan University. Changing the project leader is not permitted
	in principle. They are responsible for overseeing the project and hold all
	responsibilities including the implementation of research strategies, concept
	development, and overall promotion of the project as a whole. In addition, they play
	a leading role in carrying out the research plan by supervising the researchers
	belonging to Ritsumeikan University and/or external research institutes of
	government, industry, and academia, as well as compiling research achievements, and
	publishing/presenting those achievements. They exchange views with the project
	members and graduate students, give advice and directions regarding research, assess
	research, and manage all other matters related to research.

	cost budget of the research project.

Note 2) The budget amounts stated above are rough estimates. The amounts will be discussed and determined by the Screening Committee.  Note 3) The basic amount of monthly salary for researchers will be 400,000 yen for Research Professors (Assistant Professors), 330,000 yen for Senior Researchers, and 270,000 yen for Researchers.  Note 4) When combining personnel costs for Research Assistant Professors, Senior Researchers, and Researchers with other budgets, approval by the Ritsumeikan Asia-Japan Research Organization is required prior to

#### 6. Screening procedure

### (1) Screening Committee

The Screening Committee of the Program for Asia-Japan Research Development, which is established under the Steering Committee of the Ritsumeikan Asia-Japan Research Organization, conducts screening in accordance with specific screening criteria. The 1st screening is a document screening and the 2nd is an interview screening. The Screening Committee is composed of on- and off-campus experts who are designated by the chairperson of the committee.

#### (2) Screening process

The following screening will be conducted for selecting projects.

- (i) Submission of application form
- (ii) Document screening (1st screening)

Projects that will proceed to the 2nd screening (interview) are selected.

(iii) Interview (2nd screening)

Interviews with project leaders and project members are conducted regarding project planning, features, research expense budget plan, etc.

(iv) Project adoption

Following the 2nd screening (interview), the projects to be adopted are selected.

#### (3) Screening criteria (common for the 1st and 2nd screenings)

- (i) The contents of the project plan are consistent with the aim of the Program for Asia-Japan Research Development.
- (ii) The project has originality, innovativeness, and a tendency to generate positive ripple effects.
- (iii) The proposed contents can earn recognition from international journals and academic societies for their research achievements.
- (iv) The development plan and research methods are appropriate and the contents are feasible.
- (v) The contents of the project are expected to be developed into a medium- or large-scale Grant-in-Aid for Scientific Research or other extramural funds after the project period is over.
- (vi) The attainment target of the project is clearly specified.
- (vii) The project plan incorporates the development of early-career researchers and graduate students (both master's and doctoral students).
- (viii) The project has been or plans to be participated by those belonging to other universities and companies, particularly those at overseas universities.
- (ix) The project plan improves the current gender equality situation.(Consider a balance so that neither gender accounts for less than 25% of the total membership in a project.)
- (x) The project plan contributes to the achievement of one or more (up to three) of the 17 Sustainable Development Goals (SDGs).
- (xi) The project plan contributes to the enhancement of the international presence of the Asia-Japan Research Institute

#### 7. Notes

- (1) An annual research plan must be submitted each academic year in addition to a progress report every semester. Progress of the project is verified and feedback is given by the Steering Committee for the Ritsumeikan Asia-Japan Research Organization through interviews, etc.
- (2) The project leader must attend the Steering Committee for the Asia-Japan Research Institute as a member of the institute.
- (3) Extramural research grants (Grants-in-Aid for Scientific Research S, A, B, etc.) must be applied for to continuously develop the project.
- (4) Two academic papers (review articles are also acceptable) and one book review must be contributed to academic journals published in English by the Asia-Japan Research Institute.
- (5) After the completion of the project, one research report written in English covering the entire research period must be submitted. If the report is not submitted, the project leader will be disqualified from applying as a project leader to this program in the future.
- (6) Efforts should be made to proactively and strategically disseminate project achievements outside of the University. With regards to media exposure such as newspapers and television, the Ritsumeikan Asia-Japan Research Organization must be notified in advance.

#### 8. Requests for projects

- (1) Cooperate with activities organized by the Ritsumeikan Asia-Japan Research Organization or Asia-Japan Research Institute. (Participate in/organize symposiums, seminars, etc.)
- (2) Select and employ Senior Researchers and Researchers based on their personality and capabilities, and also make efforts to develop their future career paths (not only in academia but also in industry) for when the research period is over.

#### 9. Restrictions regarding multiple applications

- (1) Applications for the AY2024 Program for Asia-Japan Research Development
  - A researcher who applies as a "project leader" in a project for the AY2024 Program for Asia-Japan Research Development may participate in another project for this program as a "project member." If both projects become candidates for adoption, their research content and scale will be considered before determining how to appropriately coordinate the research.
  - Applications as "project leader" for multiple projects for the AY2024 Program for Asia-Japan Research Development shall not be permitted. However, participation in this program as a "project member" is possible.
  - "Project leaders" who were selected for the Second-phase Program for Asia-Japan Research Development in previous years and have remaining research period in AY2024 or later may not apply to be a "project leader" for the AY2024 Program for Asia-Japan Research Development.
- (2) Applications from project leaders of other research program's in Advanced Research Programs
  - A Project Leader or Group Leader for the "Forth-Phase R-GIRO Research Program" may not apply to be a "Project Leader" of the AY2024 Program for Asia-Japan Research Development.

#### 10. Application procedure

Applications must be made by submitting via e-mail the prescribed application forms to the relevant Research Office.

# 11. Guidance for application

The Ritsumeikan Asia-Japan Research Organization will hold a Zoom online guidance on applications for the Second-phase Program for Asia-Japan Research Development. At the guidance, the Organization will explain the aims and content of the program, application requirements, schedules and other points.
